





POLICY AND PROCEDURES FOR COFFEE HOUR

Policy:

- 1. A coffee hour is provided after the 10:30 AM service by volunteers of the church.
- 2. The church will provide coffee, tea, creamer, and sweeteners.
- 3. The church will provide cups, plates, napkins, and silverware.
- 4. The church will provide drink concentrate(?) and ice.
- 5. Those who volunteer for running the coffee hour will provide snacks.
- 6. Volunteers will make the coffee, tea, and punch and set it out on the table provided along with snacks. Please make both Reg & Decaf (Somne members can't have the caffeine.
- 7. Volunteers will remove all items, clean up the dishes and table, and place items used in their normal storage areas.
- 8. They will also wash towels used and bring them back to the church towel drawer.

Procedure:

A person from the Randy Fowler purchase the church provided items listed above and place these supplies in their appropriate areas for coffee hour access.

Alma Short will set up a sign up sheet for volunteers to run the coffee hour on each Sunday throughout the year, remind volunteers of their designated coffee hour Sunday, and orient new volunteers on the policies and procedures regarding coffee hour responsibilities including where supplies are kept.

Volunteers on their designated coffee hour Sunday will:

- A. Turn on the coffee maker to warm the water.
- B. Make a pot of hot water with the coffee maker for tea, and place it on an activated warmer plate.
- C. Make a pot of regular and decaf coffee and put them on an activated warmer plate.
- D. Make the punch in a punch bowl with water and ice, and place it on the serving table.
- E. Place the plates, cups, napkins, silverware, creamer, and sweeteners on the serving table.
- F. Place their snacks on plates on the serving table with appropriate serving utensils.
- G. Monitor the table as people come through the serving line and assist as needed.
- H. After serving is completed clean the coffee pots, punch bowl, and other utensils and dishes used for the coffee hour and return them to their storage areas.
- I. Turn off the coffee maker and warmer plates.
- J. Clean the Serving table and counters used.
- K. Notify person in charge of purchasing what coffee hour supplies need to be replenished.





OROVILLE'S NEW METHODIST CHURCH

CHURCH CORNER STONE LAID WITH RITUALISTIC SERVICES

HISTORY OF CHURCH RECALLS INTERESTING PERIODS OF EARLY
DAYS OF OROVILLE

With the impressive ritualistic services of the church and of the Masonic fraternity, the corner-stone of the new Methodist Church was laid in its place last evening. The program that had been prepared for the occasion was listened to with close attention. The program was substantially the same as that published yesterday.

Following the exercises at the church site, an adjournment was taken to the Court-house Square, where the Rev. Dr. Beeks delivered a strong and earnest address.

One of the most interesting features of the service was the reading of the church history by the Rev. G. M. Richmond. This history recalled much of the earlier history of Oroville, and was prof particular interest to the older residents.

History of Church.

The history of the church has been das follows:

In writing a history of the Methodist Episcopal Church of Oroville, it is very evident that the facts of the very early history must be somewhat mingled with tradition.

Up to this period we have sought out every available avenue of authentic record open to us, and offer this brief record as free from errors as possible. We think that all errors hereafter discoverable will not be of a serious na-

The first authentic record which we have of the beginnings of the First M thodist Episcopal Church of Orovue, materially speaking, was December 11, 1857, when Conrad Hoover deeded to the trustees of the church, consisting of J. J. Cleveland, P. P.

J. Cleveland, P. P. Caine, R. C. Gridley, J. R. Wells and Thomas Lytle, the south corner of Lincoln and Robinson Streets, being 66 feet frontage on Robinson Street and a depth of 132 feet on Lincoln Street, for a consideration of \$715.

On December 23, 1858, these same trustees mortgaged the property to John J. Buckeris for \$600 at 2½% per month interest.

We note that on October 13, 1860, the trustees gave a mortgage to Randall Hobart for \$450 at 2½% per month interest. This mortgage was satisfied March 13, 1862.

At this time the trustees consisted of John R. Wells, L. A. Goodhead and G. W. Sovereign.

It appears from the record that these trustees deeded the property to John J. Buckeris, March 13, 1862, for a consideration of \$1,136.

From reliable sources we are assured that this must have been the satisfaction of a mortgage held by John J. Buckeris.

About this time the Frazer River mining excitement broke out and many of our people left the city, and the depleted, struggling society finding it impossible to carry the mortgage, succumbed to the inevitable and the Methodist Society lost their property and largely their foothold in the city of Oroville.

With the passing of the lot heretofore described went also the Methodist parsonage. When and by whom this parsonage was built is a matter of conjecture largely. The oldest residents of the city at this present date remember its existence from their earliest residence in the city. It was a one-story brick structure of four rooms, but those who occupied it latterly had made additions, which materially changed its appearance, and thus the floods came and the winds blew and beat upon that house, but it fell not, because of its superior construction of our early builders, until April, 1910, when modern builders razed it for the 20,000 brick which it contained to erect within a few feet of the ancient location the new, modern and more beautiful and more convenient structure.

However fascinating is this early history, we must leave it, so the annals have a sudden and abrupt termination.

From 1857 to 1863 we can trace a tolerably correct record, but from 1863 until 1878 our history is all but silent. We doubt not that during this period of fifteen years between 1863 and 1878 some labor was bestowed by the Methodists, but it must have been scattering, unsystematic and incoherent.

However, that period is wrapped in too deep silence for much more than conjecture.

On June 16, 1910, the corner-stone of the old church was removed and opened and contents noted. Several interesting relics were found enclosed, among which were copies of the county papers, a copy of the California Christian Advocate, a Bible, a Methodist Hymnal, a photo of Rev. J. W. Kuykendall, a list of the subscribers to the then new church, and a history of the church up to that period. From that period we shall make free use of the record left by him in the corner-stone.

From the county records we find that the church society was incorporated as "The First Methodist Church of Oroville" on the 14th of May, 1878.

From the records of J. W. Kuykendall we quote the following:

"First Methodist Episcopal Church, Oroville, Butte County, California. William Dunstone, G. W. Sovereign, and Gardner Osgood, trustees. John Wesley Kuykendall, pastor; Rev. A. J. Nelson, presiding elder, Sacramento District, California Conference. (Box sealed and deposited in corner-stone, April 7, 1879.)

"A brief account of the Oroville charge, Sacramento District, California Conference:

"Efforts have been made at several different times in the past to establish Methodism in Oroville, but nothing permanent was accomplished until about a year ago. Brother S. Jones, whose pastorate on this charge closed in September, 1874, was the last pastor appointed by the conference until the present one. John W. Kuykendall, who was appointed September 30, 1878. Brother J. W. Sheehan, who was laboring on the Chico circuit, visited Oroville in December, 1877, and preached a few times and arranged to hold reg-

ular services.

"In February, 1878, he organized a class here, with the following names: G. W. Sovereign, William Dunstone (full members from old record); Mrs. Virginia Welch (by letter); William fedmonds, Mrs. Edmonds, Charles Gummow, Laura Gummow, John Moler, Caroline Moler, Caroline Gummow, Elizabeth Smith (joined on trial).

"Only a few days after the organization of this class Brother Sheehan was drowned in Butte Creek while on his way from Oroville to his home at Durham. Brother Sheehan was very much beloved by the people of this place, and they felt his loss keenly. He did much good during his short pastorate. About a month after his death, Rev. John Tamblyn, a local preacher of the M. E. Church, was employed by the presiding elder of this district (Rev. A. J. Nelson) to take charge for the remainder of the year. He filled the place very acceptably, and added a few names to the membership, but on account of ill-health had to kave the work a month before conference.

"During Brother Tamblyn's pastorate a lot was secured on which to build a church, and mostly paid for, but no effort was made to secure subscriptions to build.

"On reaching the charge I found but a very small membership and all limited in means. Also found the town and surrounding country in a financial depression, and it was only by earnest and persistent effort that we could secure by subscription enough to make a beginning.

"On the evening of the 4th day of April, 1879, we laid the corner-stone in which this document is found. The congregation assembled at the Courthouse, and Rev. W. S. Urmy, of Chico, delivered a very interesting and appropriate sermon from Deut. 32: 31, after which about \$75 was added to the subscription list and a plate collection of \$14 taken. The congregation then repaired to the church lot, where Brother Urmy conducted the services and laid the corner-stone, assisted by Rev. Jesse Wood, of the Congregational Church of Oroville, and the pastor of the M. E. Church.

"At the close of the service the pastor stated that the names of all the subscribers for the building would be placed in the corner-stone, and that it would be a few days before the box would be sealed up.

"The next morning Brother Urmy and myself and Brother Osgood went

to work to secure subscriptions, and succeeded, as the list enclosed in this box will show.

"Brother Urmy's visits and labors have greatly assisted us in our effort. May the blessing of the Lord rest upon him and may he be abundantly rewarded.

"As pastor, I wish to record a word of thanks to the good people of Oroville for their uniform kindness to myself and wife. I am especially grateful to all who have aided us in this work by their contributions and their words of encouragement and their sympathy, which have cheered our hearts and sustained our hands amid the many discouragements we have passed through in the past few months.

"We feel confident of success in this good work.

"May the grace of our Lord Jesus Christ, and the love of the Father and the communion of the Holy Spirit ever rest upon us all. Amen. "J. W. Kuykendall,"
"Preacher in Charge."

Thus reads the history of the laying of the corner-stone of what is now known as the old church.

We feel at this date that we are enabled to record a correct succession of the various pastorates, giving names of pastors, dates, and years of service, beginning with 1857 down to 1910. As before stated, the work of the Methodists began at Oroville ander J. R. Tansey ip 1857.

According to the records, he served the charge one year. He is classed among the pioneer preachers of Methodism in the State. (Deceased, June 20, 1876.)

While there is some uncertainty regarding it, it appears that the charge was occupied in 1858 by R. B. Stratton. Little is known of this pastorate beyond the fact that Mr. Stratton returned to New York during this same year. (Deceased, January 25, 1875.)

From the record we are assured that the charge was occupied in 1860 by Randall Hobart. As there was not another appointment made to the charge until 1863, it is presumed that he may have served the charge during this entire period, for it is known that he was county judge when the county-seat was located at Bidwell's Bar. The fact that he took a superanuate relation in 1861 warrants the presumption. (Deceased, February 7, 1870.)

Philetus Grove was appointed to the charge in 1863. Very little is known of the work during this pastorate. At this period Oroville and Forbestown were together, but for some reason the work was abandoned during this year and was not revived until some years later. How long Mr. Grove remained pastor is not known. (Deceased, December 30, 1869.)

Although omitted by some of our records, it is quite certain that the charge was served by Seneca Jones during the years 1874-5. Little is known of the accomplishments during this period. Seneca Jones is still in pastoral service, in the Congregational Church.

W. J. Sheehan, who was laboring on the Chico circuit, visited Oroville in December, 1877. In February, 1878, he organized a class consisting of G. W. Sovereign, William Dunstone, Mrs. Virginia Welch, William Edmonds and wife, Charles Gummow, Laura Gummow, Caroline Gummow, John Moler and wife, and Elizabeth Smith. He was drowned soon after while attempting to ford Butte Creek in discharge of his-circuit duties.

About a month after his death, John Tamblyn, a local preacher of the M. E. Church, was employed. Filled out the year acceptably, but on account of ill-health left the charge about a month before conference. During his pastorate a lot was secured on which to build a church and was mostly paid for, but no subscriptions secured toward a new church.

At the conference of 1878, on the 20th of September, J. W. Kuykendall was appointed as pastor. The splendid work of this pastorate has already been noted, as to how a few months later, April 4, 1879, the corner-stone of a new church was laid, and that the building then planned for has served the society to the present date.

J. Gregory was sent to the charge in the fall of 1879, and served the church one year. Little is known of his work beyond the fact of his term of service, and nothing about his later movements.

At the September conference of 1880, John Appleton was sent to the charge, and served it three years, during which time the church was finished and a lot on the corner of Montgomery Street and Second Avenue purchased, upon which a parsonage was built.

In 1883, Jess Smith was appointed, but for some reason served the charge but six months. The remainder of the year was supplied by Brother Warren.

Richard Rodda was sent to the charge at the conference of 1884, and served the society for three years. During this pastprate the belfry was

finished and a bell purchased and

In 1886, John Kirby was appointed, and served a pastorate of two years. During this period the church was relieved of its debt and dedicated. We feel that special mention should be made of the fact that largely through the earnest and untiring efforts of Mrs. John Smith and Mrs. Samuel Gummow (who later became Mrs. J. C. Weldon) in raising funds, this indebtedness was discharged.

C. H. Beechgood was appointed to the charge in 1888. He remained one year. Little is known concerning this pastorate beyond the fact that the paster and people worked on in peace and harmony.

According to the records, the charge was supplied by J. P. Morris during the year 1889. Further records seem unavailable.

F. E. McCallum was the appointee in the fall of 1890. But like the pastorate preceding it, data regarding conditions and accomplishments are very scant.

At the conference of 1891, A. C. Duncan was appointed to the charge, and served it but one year. Like some other pastorates, we must acknowledge inability to secure much regarding the accomplishments of the church during this period.

On August 19, 1891, this society purchased a property on Lincoln Street, between Miners Alley and the church (corner of Lincoln and Bird Streets), for a parsonage property. This, however, was not used as a parsonage until 1894. The parsonage on corner of Montgomery Street and Second Avenue being used until 1894, when it was sold.

Angelo Canoll was appointed in 1892 and served the charge two years. He was a preacher of exceptional mental power, as well as of religious fervor and eloquence. Even to the present day we hear of his marvelous pulpit ability, and it is not surprising that a volume of those remarkable discourses should be published. That work is now extant. (Deceased, March 28, 1895)

In 1894, Daniel M. Birmingham was appointed, and served the charge two years. It was during this pastorate that the parsonage property on the corner of Montgomery Street and Second Avenue was sold and the new property occupied which was purchased in 1891, on the east side of Lincoln Street, lying between Miners Alley and the church lot on the corner of Bird and Lincoln Street. This building was occupied several years thereafter as a parsonage. This pasn torate was one of reconstruction and reuniting the church forces. The pasn tor by his kindly manner greatly enn deared himself to all. He is still in active service, in New York City.

G. H. Van Vliet received the appointment to this charge in 1895, and served the society for four years. His term of service was marked by a succession of successful revivals, resulting in a large ingathering of members. About \$590 was spent in renovating the church. The vacant lot adjoining the church on the east was also purchased during this pastorate. Brother Van Vliet still resides near the city, and we are frequently cheered by his presence and sympathetic advice.

In the year 1900, C. H. Beechgood was appointed to the charge for a second time. He served but eight months of this year, however, owing to failure of voice, and resigned. Fred Shelton was appointed by the presiding elder to supply for the remainder of the year.

D. W. Chilson was appointed to Oroville in the fall of 1901. His term of service lasted but one year. Our data are meager concerning this pastorate and little is known during this period, other than the ordinary course of pastoral service.

In 1902, Horace E. Beeks was appointed. He was returned in 1903, but owing to throat trouble served only a few months. He was succeeded by Fred Shelton, who supplied the remainder of the year. His incumbency was marked by additions to the church and a general feeling of good fellowship. During this pastorate the old parsonage building was torn down and a modern, nine-room dwelling erected in its stead, at a cost of \$2,500, A balance of \$1,100 of this debt was carried until 1906, when it was canceled. Dr. Beeks is now district superintendent of the Sacramento District.

At the conference of 1904, J. W. Phelps was appointed. He served the charge for three years. During his incumbency the remaining indebtedness on the parsonage was paid. We note that it was about this period when the agitation concerning a new church edifice began. It is known that a subscription list was started, but the matter was finally dropped. Mr. Phelps is still in active service in the conference.

James L Case was the next incumbent. He was appointed in September, 1907, and served two years. The agitation relative to a new church continued more or less during this pastorate also, but nothing other than the agitation was effected, though the idea was evidently brewing in the minds of the people. A notable revival took place on the charge during this pastorate, and the church was greatly quickened and many were added to the church. Mr. Case is actively engaged in the conference at the present writing.

We have finally reached the period of the present pastorate.

G. M. Richmond was appointed to Oroville, September 20, 1969. On arriving in the city we found the spirit of the entire city one of hopefulness and aggressiveness. This spirit was shared by the people in the church regarding spiritual things. Our little church, which had served the society so long, was often taxed to accommodate those who sought an entrance to the services on the Sabbath. It was also found that the cramped condition of this building was inadequate for the larger growth that promised, and accordingly on the evening of December 1, 1909, at a regular official board meeting, it was moved by V. B. Howe and seconded by Fred Irwin, that we build a new church.

The question soon arose as to location. Some still clung sympathetically to the location which had become famous as the "Methodist" corner, while others thought that a change might be made which would be advantageous both as to location and financially, as in the exchange of properties there would be a difference of several thousand dollars.

In a short time an option was secured on what was known as the Woolever lot. It was the southeast corner of Lincoln and Robinson Streets.

This option was to expire on March 15, 1910. The church took it up and arranged for its purchase at \$7,000. In this transaction the church secured a lot 66x128, and on this stood at the time of purchase a one-story brick house, which was bought in the purchase. Strange as it may seem, this house was the Methodist parsonage mentioned in the early period of this historical narrative, and the lot was the same as that lost through the foreelosure of a mortgage many years ago, with the addition of six feet.

Thus the old saying was true again, \$
"God works in a mysterious way His wonders to perform."

We are, then, located on the exact spot which our forefathers purchased and lost.

On April 16, 1910, the Methodists broke ground for their new church and parsonage, as they had sold out their church and parsonage on Bird and Lincoln Streets. An appropriate program was arranged for the occasion, and about this time the old brick house (formerly the parsonage) was razed and the brick used in the new

parsonage, which is just about completed at this writing. It is a twostory house of eight rooms, with every modern convenience. The first story is of brick and the second is frame, and the whole is covered with cement plaster. At this writing the cost of this building is approximately \$2,700.

The foundation of the new church is now laid. The building is 67x86, with a basement under the whole. The foundation walls are of concrete, 16 inches thick. The frame work on the basement walls is now being constructed, and we are ready for the laying of our corner-stone to-night at 7 o'clock.


THURSDAY NEXT TO SEE OLD STONE OPENED

INTERESTING HISTORY REVEALED WHEN CORNER STONE IS OPENED

NUMBER PRESENT AT SERVICES AT METHODIST CHURCH LAST EVENING.

The corner-stone of the Methodist Church in this city was taken from the place that it has been resting for the past thirty-one years, last evening, and opened. The exercises were very simple and informal, and centered largely around an examination of the contents of the corner-stone. Many of the older residents of Oroville were present, and the documents exhibited and names read recalled earlier days with great vividness.

The stone was put in place on Friday, April 4, 1879. It is proposed to make the same stone the corner-stone of the new structure. According to present plans, it will be laid in its new place on Friday, July 8, 1910. The presiding elder, Rev. H. E. Beeks, will be present on that occasion. The members of Orovitle Lodge, Number 103, F. and A. M., have also been invited to participate in the ceremonies.

Contents of Stone.

Among the more interesting contents of the corner-stone were the local papers, a list of the persons who had contributed to build the church, and a brief history of the church by its then pastor, the Rev. Mr. Kuykendall.

The first paper taken out was the Butte County Register, now the Oroville Daily Register. At that time the paper was published in Biggs. Its editor was William Sharkey, the father of Mrs. M. S. Abrams and Walter J. Sharkey, of this city.

The Chico Enterprise was also a weekly paper. Ed Hoole was the editor. The only evening paper was the Chico Daily Evening Record, then a small four-page sheet for which the modest sum of \$10 a year was asked. George H. Crossette edited the Record. The Weekly Mercury, published in Oroville, was the fourth local paper that the corner-stone contained. It was published by William DeMott.

The following history of the church will be read with interest:

First Methodist Episcopal Church, Oroville, Butte County, California. William Dunstone, G. W. Sovereign and, Gardner Osgood, trustees; John Wesley Kuykendall, pastor; Rev. A. J. Nelson, presiding elder Sacramento District, California Conference, (Box scaled and deposited in corner-stone, April 7, 1879.) A brief account of the Oroville charge, Sucramento District, California Conference:

Efforts have been made at several different times in the past to establish Methodism in Oroville, but nothins permanent was accomplished until about a year ago. Brother S. Jones, whose pastorate on this charge closed in September, 1874, was the last pastor appointed by the Conference until the present one, John W. Kuykendall, who was appointed September 30, 1878.

Brother W. J. Sheehan, who was laboring on the Chico circuit, visited of Oroville in December, 1877, and preached a few times and arranged to hold regular services.

In February, 1878, he organized a class here, with the following names: G. W. Sovereign, William Dunstone (full members from old record), Mrs. Virginia Welch (by letter), William Edmonds, Mrs. Edmonds, Charles Gummow, Lauria Gummow, John Moler, Caroline Moler, Caroline Gummow, Elizabeth Smith (joined on trial).

Only a few days after the organization of this class, Brother Sheehan was drowned in Butte Creek while on his way from Oroville to his home at Durham. Brother Sheehan was very much beloved by the people of this place, and they felt his loss keenly. He did much good during his short pastorate. About a month after his death, Rev. John Tamblyn, a local preacher of the

About a month after his death, Rev. John Tamblyn, a local preacher of the M. E. Church, was employed by the presiding elder of this district (Rev. A. J. Nelson) to take charge for the remainder of the year. He filled the place very acceptably and added a few names to the membership, but on account of ill health, had to leave the

work a month before conference.

During Brother Tamblyn's pastorate, a lot was secured on which to build a church and mostly paid for, but no effort made to secure subscriptions to build.

On reaching the charge I found but a very small membership, and they all

limited in means. Also found the town and surrounding country in a financial depression, and it was only by earnest and persistent effort that we could secure by subscription enough to make a beginning.

On the evening of the 4th day of April, 1879, we laid the corner-stone in which this document is found. The congregation assembled at the Courthouse, and Rev, W. S. Urmy, of Chico, delivered a very interesting and appropriate sermon from Deut. 32:31, after which about \$75 was added to the subscription list, and a plate-collection of \$14 taken. The congregation then repaired to the church lot, where Brother Urmy conducted the services and laid the corner-stone, assisted by Rev. Jesse Wood, of the Congregational Church of Oroville, and the pastor of the M. E. Church.

At the close of the service the pastor stated that the names of all the subscribers for the building would be placed in the corner-stone and that it would be a few days before the box would be sealed up. The next morning Brother Urmy and myself, Brother Osgood, went to work to secure subscriptions, and succeeded, as the list enclosed in this box will show.

Brother Urmy's visits and labors have greatly assisted us in our effort. May the blessing of the Lord rest upon him and may he be abundantly rewarded. As pastor, I wish to record a word of thanks to the good people of Oroville for their uniform kindness to myself and wife. I am especially grateful to all who have aided us in this work by their contributions and their words of encouragement and their sympathy, which have cheered our hearts and sustained our hands amid the many discouragements we have passed through in the past few months.

We feel confident of success in this good work.

May the grace of our Lord, Jesus Christ, and love of the Father and the communion of the Holy Spirit ever rest upon us all. Amen. J. W. KUYKENDALL,

SENATOR PERKINS GIVES NEW BELL TO METHODIST CHURCH

WRITES INTERESTING LETTER TELLING OF EARLY DAYS IN OROVILLE.

Senator George C. Perkins has written Mr. A. Vaughan, of the Finance Committee of the Methodist Church, a letter in which he offers to purchase a bell for the new church. In his letter Senator Perkins makes interesting references to the early days of Oroville. In view of the correspondence that Mr. Vaughan has had with the railroads for lower freight rates, and the agitation for a

freight rates, and the agitation for a Feather open to navigation from Oroville to the sea, the certain excerpts from the letter will be read with particular interest.

Senator Perkins' letter was writtenfrom his Oakland home. In part, he writes as follows:

"Oakland, July 21, 1910.

"Dear Mr. Vaughan:

"Your favor of recent date came duly to hand, and your remarks have my careful consideration in relation to the new Methodist Church which you are building in Oroville. I remember the site of the old parsonage, on the corner of Robinson and Lincoln Streets, which was a small house built for the Methodist minister who lived there at that time, I think in the year 1858. At that time I was driving a wagon for a grocery store in Oroville, then known as the town of Ophir.

"If, when your church is completed, you will write to me, I think I can afford to present it a bell similar to the one now in the Congregational

Church; providing you will advise me about the weight and size that would be suitable for the belfry which you propose erecting.

"It may be interesting for me to state that my first recollection of a churchman in Oroville was Rev. Mr. Seymore, a Congregational clergyman who used to preach in a little wooden shack on the west side of Montgomery Street, near Bird Street, under which Mr. Hendee had a photograph gallery, which was then called a daguerrean gallery. Later, Rev. Mr. Hiram Cummings, who lived at Garden Ranch, used to preach in Oroville every two weeks. His daughter was married to a Mr. A. S. Hart, who was at that time a very prominent mining man, engaged in fluming the Feather River.

"Few of the old residents now living in Oroville, if any, were there at that time. Judge Lott, I think, then lived at Bidwell's Bar, while Judge Gray was teaching school in the Wyandotte district, I think; and Colonel Batchelder was also a teacher in one of the public schools of the county, but this was in later years than the time tof which I have been speaking. George Dyer, for whom I worked for a number of months, is yet living in Oro-

ville. I was paid \$2 a night for running a wheelbarrow, stripping off the top gravel at his mining claim on the Peather River.

"I noticed by the Oroville papers that you had a water carnival in Oroville some time since, which seemed to have been a gala occasion. It reminded me of the winter of 1869 and 1861, when I went down the river in a small boat and chartered the first river steamer that ever reached the town of Oroville, to bring up a cargo of supplies. As I say, this was the first steamer that ever reached the town of Ophir, and the last; although one a few years previously came up as far the Rancheria, a few miles below Oroville.

"I started down the river, I remember, with an old sailor, by the name of "Jim" Downs, We left early in the morning, and I was not aware that he had been imbibing too freely. As soon as we crossed the first riffle the boat half filled with water, and it then dawned upon me that Downs was half seas over. He begged me to put him ashore, as he did not want to be drowned in fresh water. I left him on a bluff near what was then known as Kent's ferry, which was the only dry spot of land that I saw, excepting the Butter in Sutter County, which loomed e; up like an island in the sea. Every-
